SECOND: The purpose for which this corporation is formed is to further the interest of amateur sports officials; maintain the highest standards of sports officiating; promote the welfare of amateur sports, its players, administrators, fans, the media and amateur sports officials; to encourage the spirit of fair play and sportsmanship; to cooperate with organizations and associations connected with all sports and all persons involved with amateur sports; to provide educational programs to advance the knowledge and skills of amateur sports officials; to conduct programs encouraging public appreciation of the skill and for the professional competence of amateur sports officials and to fully cooperate with and work in association with the Oklahoma Secondary Schools Activity Association by following their Constitution, By-Laws, rules and regulations and recommendations.
